Executive Director's Report

As I stand on the threshold of the beginning of my tenth year as the Executive Director of the DLC, I have been reflecting on all that has brought us to this moment as we begin this 55th meeting of the Conference. As the LCWR celebrated its 50th Jubilee this year, Mary Daniel Turner, SNDdeN, who has a 35-year association with LCWR, as member and Executive Director, stated that *through the conference the separation, isolation, and subtle competitiveness that had distinguished congregations of women religious were transformed into relationships marked by passion for the commonweal of the church and the world.*

I believe that the same is true for the DLC. The collaboration and building of relationships engendered through the DLC among the elected leadership of the sisters and the friars over these 71 years has transformed us so we can take bold steps to move over the threshold and through the door to praise, to bless, and to preach in this moment in time.

I am so blessed to minister with the elected members of Executive Committee: Toni Harris, Roberto Corral, Anne Kilbride, Meg Sweeney, Adrian Dover, and the DLC Staff: Eileen Gannon, Anne Lythgoe, and Barbara Suessmann. These Dominicans provided time, energy, great ideas, and accomplished good work for the Conference following the Annual Meeting in Houston last October.

During this year, we drafted goals for the next five years, worked with the Dues Committee to propose options

for dues for the next 3 years, launched the first fund raiser to help meet expenses and find other sources of income, planned the Annual Meeting, considered the overlap with the DLC Preaching Committee and DLC Communications Committee and decided to work with the existing structures of the Promoters of Preaching and OPCOMNET. We created a Task Force on Reconfiguration, and formed a partnership with Dominican University to launch the *McGreal Center for Dominican Historical Studies.*

As we begin our time in Sinsinawa, let us stand on this threshold of a new day together. Let us consider opportunities and possibilities and not snag our sleeves on obstacles, differences, or fears as we move out the door. Let us walk through the door and many other doors *together* as sons and daughters, brothers and sisters, lay and religious, as we catch the fire from Dominic's vision and throw it!

This year, both the list serve and the DLC website were migrated to a commercial service to assure more dependable communication. **(DLC's new address: www.domlife.org/dlc).**

This change was made at the request of St. Albert Province. Al Judy, OP and his brothers, have been pioneers in providing the technology and service that allowed many Dominican groups to preach in the digital age. The province is bringing this service to an end because of aging equipment and changing technology. We are very grateful to our brothers for this innovative ministry.

The work of DLC communications has become more and more integral to the work we all pursue for justice, for preaching the Word and

for connecting the diversity and complexity of Dominican Life today. Continually, the office is about the work of connection and building relationships that reflect the DLC's mission statement.

Communicators continue to develop their sense of the larger picture and devote energy to working with preachers and justice promoters. Recently, the DLC refined its relationship with the communicators (OPCOMNET), the network of congregations and provinces. The Network functions as an organizing body for communicators with its own planning committee. It previously functioned as a committee of the DLC. We will continue to work together to build relationships among congregations and provinces. The annual OPCOMNET conference will visit New



Orleans in 2007 and report on the present realities of the Dominican Family in a post hurricane Katrina world.

OPCOMNET will also celebrate its tenth anniversary in 2007.

As we see that we are one, if not in structure, then in mind and heart, there is brand new day on the horizon. The communications office will continue to find ways to create connections that make that unity more real to all of us.

Dominicans at the United Nations/ New York

I invite all Dominicans around the world to join together in prayer for peace on September 21, 2006, a day designated by the United Nations as International Day of Peace. (Carlos Azpiroz Costa, OP)

We commit ourselves to work for justice by joining the rest of the Church in realizing the Millennium Development Goals, signed by all governments in 2000, to relieve our world of dehumanizing poverty and to promote integral human development. (Fanjeaux Document)

For me, these two statements reflect great significance. When the

DLC affirmed affiliation with the United Nations, it was hoped that our platform for justice would be stretched to include the whole world, and would offer a venue for the experiences and knowledge of our sisters and brothers as we joined with others to influence the world community. This is important, but it is only half the equation.

The other hope was that this connection with the United Nations would influence us, would in turn invite our participation and would put our experience within a larger context. Both the International Day for Peace and the Millennium Development Goals are UN initiatives; both can include our preaching for

justice and both offer us the opportunity to join the world community. This I believe is very significant; we are growing in our comprehension of ourselves as members of a worldwide Order, a Family living in many countries. The UN presence contributes to this understanding.

Project OPUS

McGreal Center for Dominican Historical Studies

Standing on the Threshold of a Brand New Day echoes the sentiments of Project OPUS! In March, 2006, the DLC and Dominican University announced a new collaborative foundation: the **Sr. Mary Nona McGreal Center for Dominican Historical Studies**. Since 1989 Sister Nona has directed the work of Project OPUS. Sister Nona's collaborative style of leadership and scholarship facilitated the acquisition of over 5,000 documents, resources and publications germane to the history of the Dominican Family in the United States.

Establishing the McGreal Center necessitates a multi-year process. The McGreal Center opened September 1, 2006. During 2006-2007, the OPUS collection will be catalogued and relocated to Dominican University. While this work is being done, the McGreal Center will continue the research, writing and publication for Volumes II and III of ***The Order of Preachers in the United States: A Family History***. As the project develops, the McGreal Center will become a research center not only for the continuing study and research on the Dominican Family in the United States but also for the wider academic community interested in the history of religious communities in the United States.

The McGreal Center will carry on OPUS's commitment to preserve, promote and to understand the history of the Dominican Family in the US. As always, we need researchers and writers. Proposed DLC Goals 2007-2012

Mission Statement

(October, 2002)*

The DLC commits itself to the following goals for 2007-2012. This commitment flows from our growing awareness of our interconnection with all of creation and with one another.

Goal 1 To facilitate an environment in which leadership can engage in meaningful dialogue about issues that affect the future of Dominican life and mission

- by uniting and supporting members and mentoring future leaders
- by utilizing our personnel and financial resources for a sustainable future
- by convening a Reconfiguration Task Force to study and link discussion among the Dominican sisters
- by examining the overlap among current structures and projects

Goal 2 To promote the Dominican charism of preaching nationally and internationally

- by collaborating with the Promoters of Preaching
- by encouraging the development of the International Commission on Preaching

- by recommending participation in the High School Preaching Conference, the College Preaching Conference, the Catholic Coalition on Preaching, and preaching workshops and programs

Goal 3 To collaborate with the North American Justice, Peace and Care of Creation Promoters

- by annually reviewing and receiving the North American *Dominican Call to Action*
- by continuing our presence as UN NGOs in New York and Geneva
- by partnering with the International Justice, Peace, and Care of Creation International Commission.

Goal 4 To nurture relationships and strengthen communication with the worldwide Dominican Family

- by collaborating with the Dominican Communication Network
- by utilizing Domlife, the DLC Listserv, other Dominican websites, and developing technologies
- by encouraging opportunities for interaction among DLC Members, DLC Affiliates, the Nuns, the Laity, and other Dominican Entities.

The DLC Executive Committee thanks all of the DLC Membership for your participation and positive response in the year long process to create five year goals for the Conference. The goals listed below are draft 4, which we will discuss and then vote to accept during the Annual Meeting.



The DLC is in the second year of a three-year commitment to this website which serves as an important communications link for the Dominican Family in the US. A complete makeover of the site was launched in May, creating a more organized appearance and easier navigation. The news section is updated bi-monthly and a free email update is sent to about 1700 subscribers; a list that grows each week. The site averages about 30,000 page visits a month.

DomLife.org offers a wide range of examples of Dominican charism and mission and invites readers to see themselves as part of a national, indeed, a world wide Dominican Family. I believe the potential this offers leadership has yet to be fully realized.

The site serves as a catalyst for important initiatives on justice and peace. A close collaboration with the North American Co-Promoters of Justice makes DomLife.org a critical link in calling Dominicans to act for justice in many different ways.

DomLife.org also makes it possible for small groups with limited resources to preach through a web presence, e.g. Collaborative Dominican Novitiate and College Preaching Program. This generates some income to help offset the cost of the site. Others have expressed interest in coming on board. The DLC's website is also now hosted here and this is an efficient use of resources for DLC. (www.domlife.org/dlc).

This year we will form an Editorial Board to assist in creating more interesting and useful content and to bring new ideas to its planning. My hope is that the site will become more interactive and offer opportunities for the exchange of ideas among diverse Dominican entities and create a new kind of disputation that is faithful to our tradition.

Reconfiguration Task Force: 20/20 Vision Task Force

At the DLC Annual Meeting in Houston, TX in October of 2005, members engaged in a facilitated conversation about the implications of the many forms of reconfiguration that are currently being pursued or considered by Dominican women's congregations in the US. After the meeting, a survey sent to the DLC membership indicated that 22 out of the 25 congregations responding were supportive of establishing a Task Force on Reconfiguration and made suggestions regarding cautions and adjustments to the purposes of such a task force.

The DLC Executive Committee invited a number of sisters to gather on July 5, 2006, presenting various congregations and experiences of collaboration and reconfiguration efforts to begin the work of the task force. The following sisters contributed to the meeting: Toni Harris (Sinsinawa/DLC Past President), Anne Kilbride (Columbus/DLC Vice President), Donna Markham (Adrian), Mary Ellen O'Grady (Sinsinawa/DLC Executive Director), Barbara Rapp (Kentucky), Lois Silva (San Rafael), and Alice Uhl (Caldwell).

After a full day of excellent conversation, sharing of insights, information, and considering the results of the survey, the group gathered made the following decisions:

1. to name the Task Force: *20/20 Vision Task Force*

2. to raise the question: *What is our 20/20 vision for Dominican life and mission in 2020?*

3. to revise the purposes of the task force based on the conversation of the day and the suggestions from the survey. (the revised purposes are listed below)

4. to invite the following sisters to become members of the working committee – Mary Ann Collins (Blauvelt), Anne Kilbride (Columbus/DLC Vice President), Mary Ellen O'Grady (Sinsinawa/DLC Executive Director), Donna Pollard (Houston), Judy Rimbey (Adrian), Joan Scanlon (Kentucky/Dominican Alliance Executive Director), Lois Silva (San Rafael) (We are grateful that all have accepted)

5. to share the summary chart of all groups compiled by the Dominican Alliance (see folder)

6. to share trends through a handout and presentation at the DLC

Purposes for the 20/20 Vision Task Force

1) to be fully aware of the collaboration and reconfiguration efforts currently being undertaken by many US Dominican congregations;

2) to build on the current efforts and experience of clustering, collaborating, and restructuring in which several US Dominican congregation are presently involved; (i.e., Avoid as much as possible the reinvention of steps already taken, the creation of duplicative structures, and the need for some to start-over.)

3) to connect all those US Dominican congregations who wish to "be at the table" in order to move beyond collaboration to structural reconfiguration;

4) to communicate regularly with both elected leaders and grassroots members of all US Dominican Congregations regarding reconfiguration possibilities.

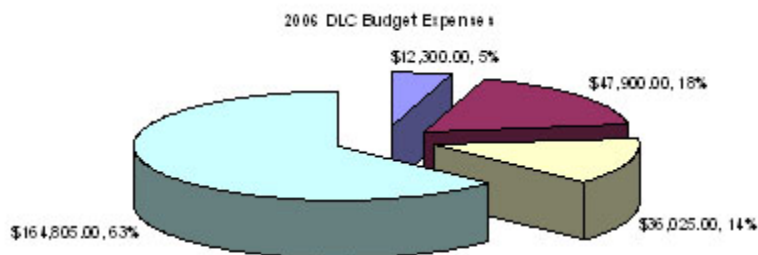
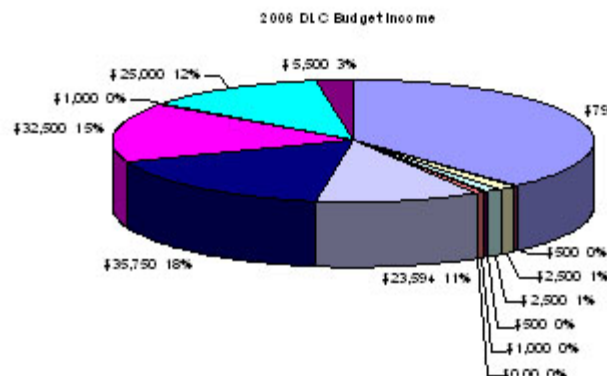

DLC Investment Commentary

DLC Invests for Dominican Life and Mission As It Stands on the Threshold of a Brand New Day

Investment Goals

To generate enough income annually to

- insure the continuance of DLC's mission of building relationships and strengthening collaborative efforts among the Dominican Family;
- support the organization's infrastructure;
- maintain membership dues at a reasonable rate.

Asset Allocation Goal

- Equity 50% / Fixed Income 50%, within +/- 10% parameter
- Cash/Money Market 5%, within +/- 5% parameter

Notes

- As of 7/31/06, the MV was \$22,483 less than last year and \$87,148 (27%) less than the original investment of \$323,000
- During 2005, \$65,800 was transferred to cover operational costs
- The income generated from the principal is insufficient to meet the DLC investment goal
- To achieve this goal, DLC needs to identify ways to increase its investment principal

Style Diversification Goal

Equity portion of the portfolio - Guidelines consist of:

- Large-cap U.S. stocks 60%, within +/-10% parameter
- Mid/small-cap U.S. stocks 25%,

within +/-10% parameter

- International stocks 10%, within +/-5% parameter
- Utilize both growth and value styles of equity management
- Social screening of all mutual funds is performed to assure that they are in accordance with SRI criteria

Fixed Income portion of the portfolio - Approved investments consist of:

- Government obligations (bonds corporate/Federal/Treasury Bills)
- Preferred stocks
- CDs (Certificates of Deposit-FDIC) in laddered positions with a date to mature greater than one year
- IIIF (Institutional Investors Income Fund) mutual fixed income funds

Style Diversification as of 7/1/06
SRI Equity Mutual Funds
Fixed Income

- As of 7/31/06, the Asset Allocation and Style Diversification are on target with the goals as stated

• The strategy of investing in a Preferred Stock at a 6.7% rate of return and in IIIF at a 6.0% rate of return has generated additional liquid funds for DLC to cover operational expenses

• Until the last week of May '06, the Fifth Third investments exhibited an increase in Unrealized Gain (URG) which maxed out at approximately \$9,500. However, from the end of May through July 31st, DLC invest-

ments exhibited an Unrealized Loss (URL) of \$886. This was the first time DLC experienced a loss in unrealized gains since its inception in 2002.

• As of July 31, 2006, the nine Socially Responsible Mutual Funds chosen for the DLC investment portfolio have out-performed the appropriate benchmarks for the YTD, as well as for the past one, three and five years. The Morningstar ratings ranked the Mutual Funds selected as follows: one as a 5 star and three as 4 stars (the highest ranks), four as 3 stars and one as a 2 star (average ranks). The Social Investment Forum in their "Socially Responsible Mutual Funds Screening and Advocacy" report listed these Mutual Funds as extremely vigorous in social screening and proxy voting activities for an average of 9 out of 11 social screen categories.

Significant Events over the Past Year

• DLC researched the value of continuing the investments in Fifth Third vs. all funds invested in IIIF.

• It was concluded that being invested in Fifth Third allows DLC the freedom to select and change the asset allocation goal, the style diversification objectives and the SRI Mutual Funds dependent on the market performance at any point in time.

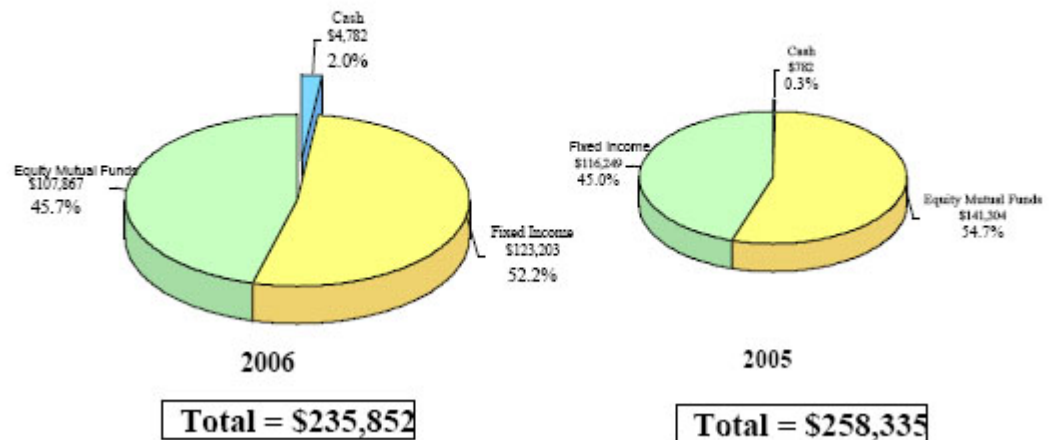
DLC can also choose the Fixed Income types, using a laddered approach that generates cash to cover a percentage of the operating costs. It was concluded that if all funds were invested in IIIF, DLC would be limited to a Fixed Income portfolio and lose the benefits of diversification.

- DLC researched the possibility of investing in iSHARES in order to include value-oriented small and mid-cap mutual funds in the portfolio as these styles were missing. iSHARES combine advantages of individual stocks with those of index funds. Like stocks, they are liquid, easy to use and can be traded in whatever number of shares preferred. Like index funds, they provide diversification, market tracking, and low expenses. In short, iSHARES are powerful investment tools that can be used to get the exposure needed, at the level wanted, at the moment it is needed. The question raised was what would this mean to the commitment of insuring that the DLC investments follow the Socially Responsible Investment criteria guidelines? The indexes do not have this as a criterion and there could be companies within the index that are not SRI focused.

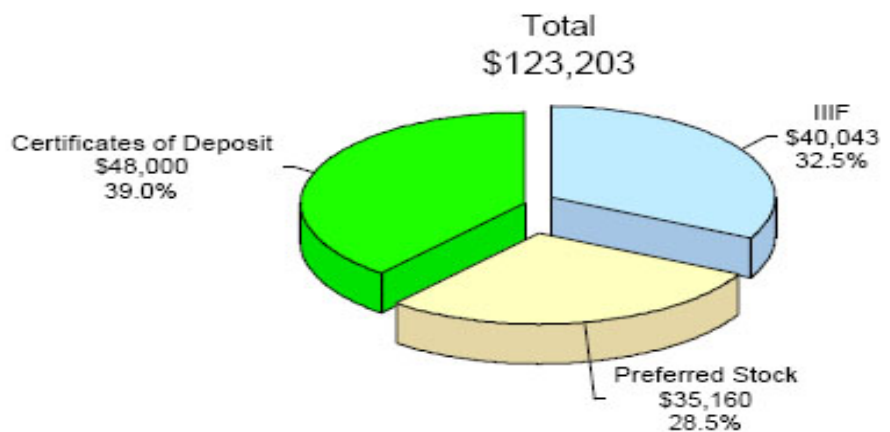
- After thorough investigation inclusive of input from financial and management consultants at Brenner, McDonagh and Tortolani (BMT), it was concluded that even though it is an acceptable strategy to implement in order to fulfill the missing components of style diversification in any investment portfolio, that the trade-off is that since the iSHARES follow a specific index, in this case a mid and small cap value style, that DLC would forfeit the assurance that the companies in the index abide by the SRI criteria. There would be no guarantees that these companies follow any, all or none of the SRI guidelines.

- Therefore, it was decided that in order not to jeopardize the commitment to the SRI criteria, DLC would not invest in iSHARES but would

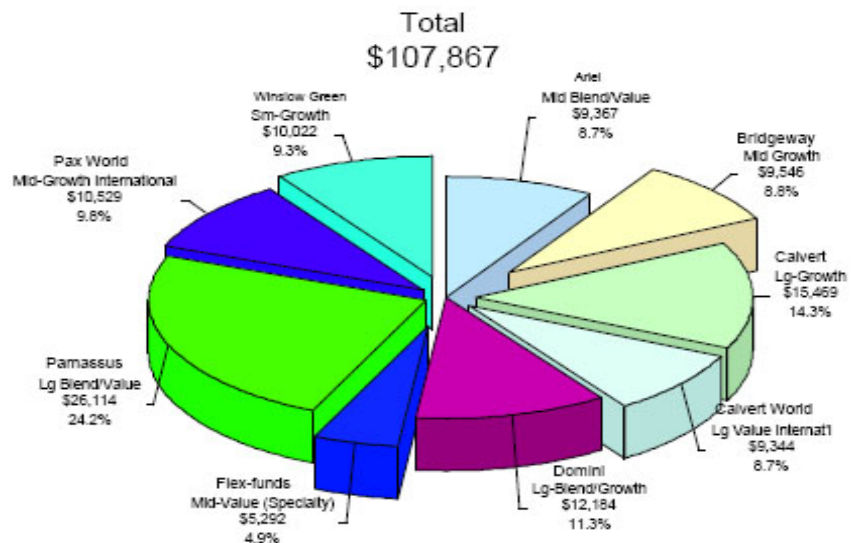
Dominican Leadership Conference (DLC) Asset Allocation July 31

direct Fifth Third to continue its investigating research activities that would identify value oriented small and mid cap SRI Equity Mutual Funds. The result was that one SRI Equity Mutual Fund [the Flex-fund, a value oriented mid-cap specialty (utilities)] was identified and added to the portfolio.

- If DLC is to continue its mission of building relationships and strengthening collaborative efforts among the Dominican Family as it stands on the threshold of a brand new day, the challenge for the year ahead is to identify creative ways of increasing the investment funds to be equal to or above the original investment amount of \$323,000.

Center for Dominican Studies (CDS)

The Center for Dominican Studies continued to hold preaching workshops this past year for clergy, for laity who publicly reflect on the Scriptures (RCIA, Wake Ministry, Nursing Home Ministry, etc.) and for Barry University student preachers who preach at university rituals. Some of the notable presenters at CDS for programs were: Sr. Helen Prejean (*Dead Man Walking: The Journey Continues*), Bp. Thomas Gumbleton (*Preaching Seeds of Hope*), Sr. Joyce Ann Zimmerman (*Liturgical Preaching*), and Fr. James Neilsen (*The Theology and Spirituality of St. Augustine through the Arts*).

The CDS staff was invited to make Faculty/Staff in-service presentations on Catholic and Dominican Identity in Catholic schools in the Archdiocese of Miami, New Orleans

and other sites. The Center was contracted by various dioceses and parishes to hold pastoral and liturgical workshops throughout the year. Sr. Mary Fran Fleischaker, OP is coordinating an on-going Taize prayer experience in the Archdiocese of Miami and holds workshops to teach the prayer method to others. The CDS sponsored three book studies throughout the academic year. The first was a mission book study for faculty and staff of Barry University. The second was a study for local clergy using Paul Philbert's book on the baptismal priesthood, *"The Priesthood of the Faithful: Key to a Living Church"* and the third was a study and critique of *The DaVinci Code* book and film.

Two **new initiatives** that the CDS is sponsoring:

Siena Center of Dominican University Completes Third Year

The Siena Center's first year, 2003-2004, involved hiring staff and initiating a handful of events, including its now-annual St. Catherine of Siena celebration.

The following year, 2004-2005, saw a focus on faithful citizenship timed just before the 2004 elections, the inauguration of the annual Albertus Magnus event on religion and science, and a spring 2005 series on community organizing

around issues of immigration and justice.

During 2005-2006, the Siena Center hosted 18 different event events, three luncheons, a day and a half conference on the relationship between liturgy and justice, and a seven-part daytime series for those in social service and justice advocacy. About one in three events featured noted Dominican speakers such as Timothy Radcliffe, OP, Barbara Reid, OP, and Donald Goergen, OP. This reflects a pattern since the beginning of the Center, which continues as the center moves into a fall season this year marked by a focus on Muslim-Catholic dialogue. Other speakers of note during 2005-2006 included John Allen, Kathleen Norris, Donald

(1) An Interfaith Children's Peace Conference for Jewish, Christian and Islamic students to learn about each others' faith traditions and to learn peace-making skills. This conference will be held in the 2006-2007 school year.

(2) A radio program called "Miraculous Minute" was started on the University's WBRY station. These one minute "preachings" allow for listeners to hear spiritual and uplifting thoughts for the day. Although many are interfaith in their perspective, a large majority of them deal with issues regarding Catholic Social Teaching and Dominicanism.

Dominican Association of Secondary Schools

During 2005-06 academic year, the *Dominican Association of Secondary Schools* continued collaborative efforts in Catholic education sustaining the 800 year legacy of the Order of Preachers.

In October 2005 the DASS Convocation, entitled *Dominican Voices for the World* with featured preachers, Timothy Radcliffe and Margaret Ormond, offered opportunities for school representatives to pray and study together.

During the National Catholic Educational Association Convention in Atlanta, DASS received an award in recognition of the 800th year anniversary of the Order and for the Dominican commitment to Catholic education. 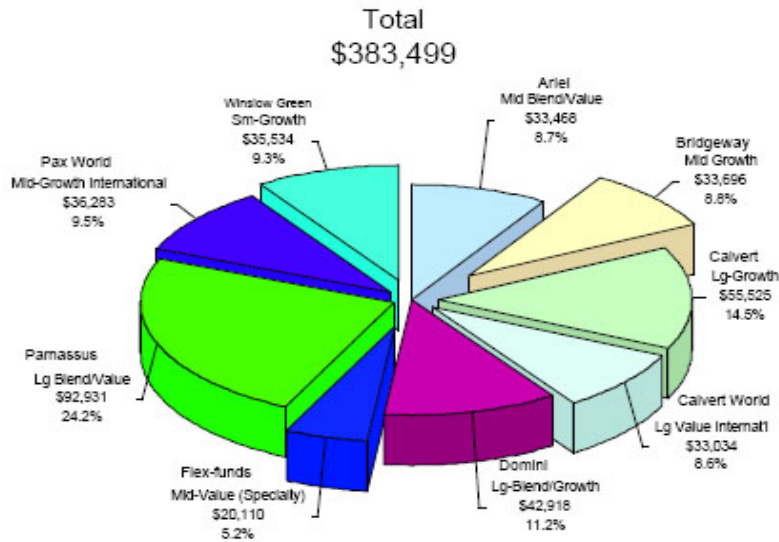
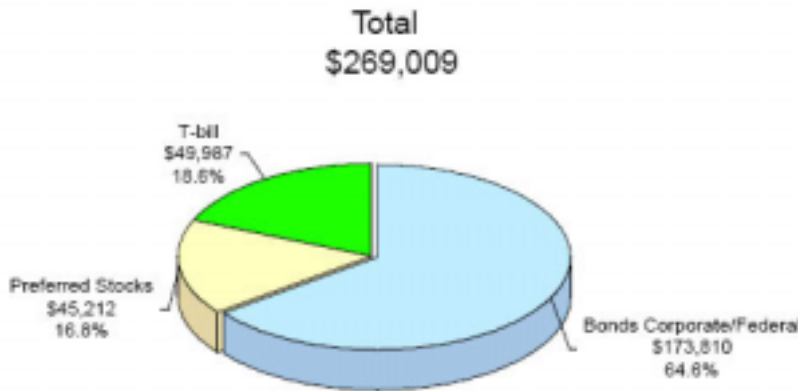

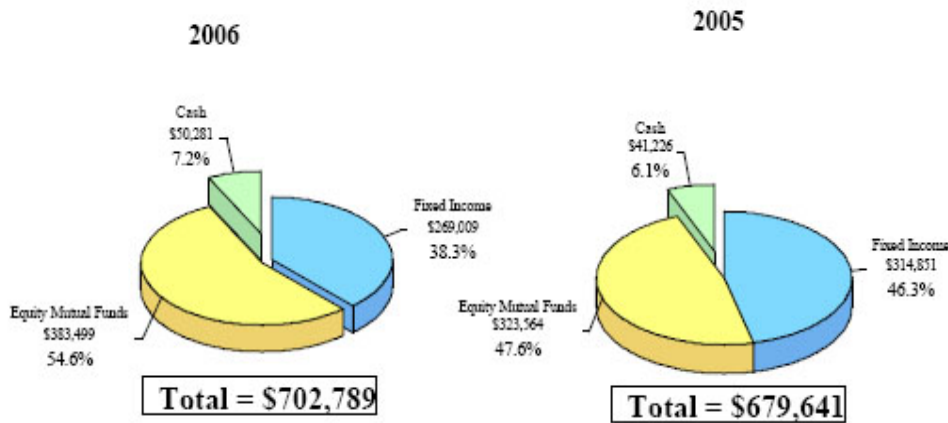

**A Catalyst for
Collaborative Preaching
among the Dominican
Family**

The initiation of the DLC/DSI Solidarity Fund in 2001 was in response to DLC's resolution: "DLC members are encouraged to demonstrate their solidarity with Dominican Sisters in Africa, Asia, Eastern Europe and Latin America/Caribbean by seriously considering making an annual donation to benefit the DLC/DSI Solidarity Fund".

The DLC/DSI Solidarity Fund offers DLC the opportunity to respond to Carmelita Murphy's challenge to organizations that "together we can accomplish what none of us can do alone". It provides an instrument for Dominicans in North America to be in solidarity with our Dominican Sisters who minister in the poorest sections of the world.

The goal of the DLC/DSI Solidarity Fund is to encourage annual contributions from DLC membership, to invest these funds for the purpose of increasing their value and to distribute 10% of the total principal invested to specific projects beyond the US borders. These grant awards are used to alleviate poverty, strengthen family life and provide educational opportunities to Dominican Sisters throughout the world. From 2001 to 2006, the total amount contributed is \$796,255 with 21% (\$247,100) distributed and 79% (\$549,155) invested. An additional 26% of funds was generated from interest/dividends over a period of 4 1/2 years (an average of 5.7% per year) and was added to the contributed monies invested. As of July 31, 2006, the total investment at market value was \$702,789. Therefore, **10% (\$70,300) will be distributed during Calendar Year 2007.**

The DLC/DSI Solidarity Funds are invested in a balanced portfolio

with Fifth Third Bank. The asset allocation, style diversification and SRI (Socially Responsible Investment) goals mirror those of DLC's [refer to the DLC Investment report on page 9]. As seen in the charts (left) DSI investments are well within the parameters stated in the guidelines.

Significant Events

Because of this partnership between DLC and DSI, a total of **\$74,897** was **contributed** from 8 congregations from September 2005 to August 2006. **88%** or **\$65,700** was **distributed** in grant awards during calendar year 2006 to the following projects:

- Dominican Sisters Africa (DSA) \$32,000 for its leadership meetings and justice and peace workshops in Tanzania;
- Dominican Sisters of Asia Pacific \$9,000 for a leadership meeting in Pakistan and for justice and peace meeting in Taiwan;
- Sisters in Eastern Europe \$9,000 for a leadership workshop in Sweden;
- Latin America/Caribbean \$9,000 to CODALC for its leadership meeting in Argentina and its justice and peace activities; and
- \$6,700 contingency funds for internet assistance for Sisters in Africa.

Future Challenge

The long term **vision** of the DLC/DSI Solidarity Fund is to **generate \$200,000 interest annually** to be distributed to projects beyond the US borders. To be collaborative preachers in solidarity with our Dominican Sisters in Africa, Asia, Eastern Europe and Latin America/Caribbean,

- Can each DLC member congregation and province choose DSI as one of its priority alternative investment projects?
- What other strategies can DLC members implement to realize DSI's long term vision?

It is with great enthusiasm that we announce the largest Dominican Volunteer program group to date, with 15 Dominican volunteers in ministry and community for 2006-2007.

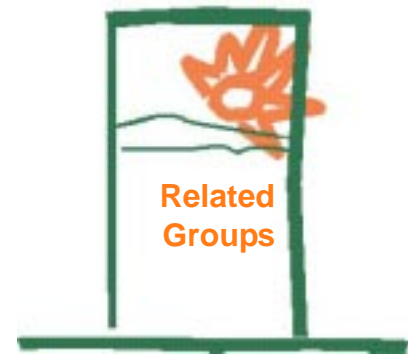

Judith Hilbing, OP and Reg McKillip, OP co-chaired the new Dominican Anti-Trafficking Committee. Sixteen congregations responded to a survey, followed by a Think Tank meeting and the creation the Dominican Trafficking Committee.

The new UN Human Rights Council of March, 2006 will have an impact on the work of Dominicans. This is the 10th Anniversary of Dominicans at the UN in Geneva. We congratulate Philippe LeBlanc, OP and the staff. This is a major reflection of the Order's commitment to Justice and Human Rights.

Eileen Gannon, OP, Philippe LeBlanc, OP and Durstynne Farnan, OP wrote letters to legislators and UN officials imploring that the U.S. implement the recommendation to

close immediately the detention centre in Guantánamo Bay and bring all detainees before an independent and competent tribunal or release them.

Fanjeaux, France was the site of the International Dominican Justice and Peace Meeting and created the "Call from Fanjeaux." It was preceded by the historic 800th Anniversary of the Order "Catching the Fire". The two North American Dominican Co-promoters attended along with Eileen Gannon, OP.

In 2005-06 Dominicans addressed: Trafficking, Immigration, Africa/AIDS, Iraq, SOA, nuclear weapons and GMO's. We participated in demonstrations on the Iraq war, immigrants, as well as workshops on the impending immigration legislation. The World Day of Migrants and Refugees was a large focus of Canadian Dominicans. Updated articles and created corporate positions on Iraq and Anti-Trafficking were held around the country.

The incredible commitment and energy of the North American Dominican Justice Promoters has made a difference.

Dominicans at the United Nations Geneva

A "momentous" change in the field of human rights protection worldwide happened at the UN when the General Assembly voted overwhelmingly on March 15, 2006 for the creation of the UN Human Rights Council that replaces the UN Commission on Human Rights which had been created in 1946. This change will have an impact on the work of Dominicans involved in human rights at the United Nations.

In a written statement at the first meeting of the Council in Geneva, in May 2006, *Dominicans for Justice and Peace* joined four international organizations, the World Council of Churches, the Lutheran World Fed-

eration, Franciscans International, and Pax Christi Internationalis in committing themselves to work with the new Human Rights Council "as a key international instrument for the promotion of justice and human dignity."

The mandate of the Order's non-governmental organization (NGO) at the UN, *Dominicans for Justice and Peace*, remains significant and relevant in terms of the new Council. However, the work will become more demanding as the Council develops its agenda and expands its mandate.

The new Council can also offer a stronger and more effective platform for raising issues that are brought forward by our brothers and sisters worldwide who are involved in the struggle for justice and human rights.

At the first meeting, the Human Rights Council made two major decisions which augur well for the future: the adoption of the International Convention on the Protection of All Persons from Enforced Disappearance and the UN Declaration on the Rights of Indigenous Peoples.
