## *Letter from the President*

This is a continuation of my letter in the April issue of *eLumen*. If you remember, I mentioned that the work of the International Congress was only part of the process and that the recommendations and proposals accepted by that Congress would have to be reviewed by each Province.

By chance, our Provincial Council was scheduled to meet at Cranberry, Penn.. starting March 29<sup>th</sup> through April 1<sup>st</sup> only four days after I returned from Argentina. Although I was a little weary and even though some of us are still struggling to adapt to changes made 25 years ago, this Province was the first in the world to consider the work of the Congress of 2007. Just to review, the Provincial Council is a representative body composed of the Regional President (see Lexicon below) and two elected delegates from each Region and, under the provision of the Rule, is charged with the government of the Province.

Since I truly believe much of our struggle and strife is created by a failure to communicate, both **what** is being done and more importantly **why** it is being done, I will attempt to be as clear as possible on both items voted by the Congress and on Provincial Council action. I have not covered all the Congress material but am listing those items that will most affect us immediately. In the actions of the Provincial Council, in addition to items that specifically addressed Congress proposals, are matters that in the spirit of self-government had to be resolved either to bring the Lay Dominicans of this Providence into conformity with the worldwide Order or specifically related to situations particular to this Province. Items from both groups that are not of such an immediate nature but are more in the way of plans and hopes for the future will be covered in another letter.

### Congress Resolution on Study and Formation

1. To develop a written formation program in each province.
2. Titles for formation, initial and ongoing formation were accepted. I have not listed all these titles as they basically follow the titles the Provincial Council decided upon several years ago. There was only one title *Peace, Justice, Care of Creation* that was added to our list.

### Provincial Council Action

*As this is one of the few Provinces that already had a written formation program, now being revised and partially complete, the questions were: do we retain this program in face of severe financial difficulties and if so, should we*

*continue with the present printed format or change to a purely electronic one. The Council voted to continue the program, to have a reduced number of printed materials but to also offer a password protected format available via Internet and to offer a CD version also. The Council also voted to assess chapters a break-even charge for either printed, password Internet or CD format. The Council voted not to redo its title list to include the one new title. Work on the novitiate series is continuing with an anticipated issue date the summer of 2007.*

**Congress Resolutions of Government: Rules and Statues/Organization and Structure - Read this section carefully!**

1. To use language befitting our identity and roles: The overall title should be Lay Dominican Fraternities/Chapters. **Dominican** names what we are. **Lay** describes the kind. [It is recognized that the term 'fraternity' is not a totally usable term for some parts of the English speaking world but it was also noted that both the Master General and the Canon Lawyer for the Order, both in attendance at the Congress requested that we remain faithful to the Latin terms of the Rule.]

*The Provincial Council accepted the reasoning and advice of both the Master General and his advisor on these terms – in this Province we are the Lay Fraternities of St. Dominic. The individual unit is for example the Holy Saints Chapter.*

2. As members of the Order proper, Lay Dominicans may use O.P. after their names thus identifying themselves as Dominicans in public. Lay Dominicans should preface their names with appropriate titles (e.g., Mr., Mrs., Ms., etc.)

*After considering this and the several proposals submitted by our members, the Council agreed to adopt this term accepting the reasoning of the Congress - again we are Dominicans and the preface identifies us (Mr. Mrs. etc.) places us as Lay members.*

3. Incorporation into the Order is through our promises, the formula for which is specified in the Rule. **Promise** is the proper term for this commitment as **Profession** is reserved for those making canonical vows.

*The Council agreed to accept this simply because canon law specifically defines the term profession. Under this designation it is understood that as Lay Dominicans we do not make vows, do not make profession, but make promises. We should conduct ourselves in accord with Church law.*

4. Each Province should revise their Directory to include Dispensation from Promises - upon the request of the Fraternity/Chapter to the Prior Provincial.
5. Each Province should revise their Directory to allow Dismissal from the Order upon the request of the Fraternity/Chapter: the Prior Provincial dismisses a member in case of lack of communion with the Church or public scandal, understanding the member has the right of appeal.

*The Council agreed to the need for both provisions on Dispensation and Dismissal. This has been a problem not only worldwide and but also in a number of our chapters over the years. The Provincial Council amended the language somewhat and is currently working on the language and procedural steps to be incorporated into the Directory.*

6. Group is the proper designation for all beginning communities before recognition as a Fraternity/Chapter.

*The Council voted to retain the Pro-Chapter designation at this time.*

7. Council – is the proper designation for organization of Lay Dominican Government at a minimum at the chapter and provincial levels.

*This addressed the problems of council government in those countries with only a few chapters (or in some cases) one chapter. Our current structure, including regional councils, is not changed by this and required no specific action.*

8. Provincial Promoter – may be friar, sister or Lay Dominican who serves as the link between the Lay Dominicans and the rest of the Family.

*This basically is directed toward those areas that have few friars or sisters and may actually use a Lay Dominican as Promoter. This does not apply to us, at present.*

9. Religious Assistant – is the designation for friar, sister, nun or Lay Dominican approved by the Prior Provincial who is the spiritual resource for the chapter. In the case of a layperson the title would be amended since a Lay Dominican is not a religious.

*This title is the most used worldwide and replaces Chaplain, Religious Promoter or other designation. The Provincial Council voted to accept the worldwide usage of the Order. This will represent a change for most of our chapters but more clearly defines this person as the spiritual resource, not a governmental element, for the chapter.*

10. President – is the designation for the elected leader of a fraternity/chapter and is the term used in the Latin text of the Rule and is most descriptive of the role. Prior or Prioress is not a proper or accepted

term.

*The Council voted to accept this term and to discourage the continued use of the terms Prior or Prioress in our chapters as these are not proper to the office, or the structure of a lay chapter and are reserved by the Church for specific persons and places.*

### **Congress Resolutions on Finance and Economy**

1. To support the upkeep of our "house" which means support for the Lay Dominican office located in Santa Sabina, Rome and to include a section on finances in the Statutes of the International Council.
2. To set an annual fee, which will be updated annually according to the Italian inflation rate, payable in advance, beginning in 2008, at the rate of 2 Euro per member per Province.
3. To establish procedure and funds for an International Congress to be held every six years.

*The Council agreed to accept this proposal. At the current Euro rate this would be approximately \$3 for each active member per year. We cannot continue to accept financial support (office, expenses) from the Order as children who need someone to pay their bills when we maintain we are an equal, vital and collaborative part of the Order. If we wish to develop plans for the future and to maintain our self-government concept we must face this financial reality. This is further discussed under Provincial Finances.*

## **ITEMS COVERED BY THE PROVINCIAL COUNCIL**

### **Clarification of the Term Lay Chapter and Membership**

Currently we are the only Province in the world that accepts clerical or other vowed persons as members of the lay fraternities. In some chapters they hold elected positions. We have been advised for sometime now by the Office of the Promoter for the Laity in Rome that this is contrary to the Rule, purpose and intent of the Lay Fraternities and should be addressed. At the same time, there are many in this status who were encouraged to become members or who entered this special status **after** becoming members of the Lay Fraternities. In charity, their status also needs to be addressed.

The Provincial Council voted on the following guidelines:

1. Priests are not to be received as members of a lay chapter but are received in the ceremony for Clerics and will follow not the Lay Rule but the separate Rule of the Clerical Fraternities.
2. Deacons, Sisters, Consecrated Virgins, Anchorites and Hermits by ordination or special vows are considered by the Church as no longer **lay** and as such cannot be received as members of a Lay Fraternity.
3. If any of these persons were received in a lay chapter prior to this they are "grandfathered (or mothered)" and may remain with the chapter, however, they may not hold office within the lay chapter. The same applies if they change their status after being received into a chapter such as a member now becoming a deacon. They may remain an associate of the chapter but may not hold office.
4. Proper ceremony and Rule of the Clerical Fraternities was made available to each regional moderator.

### **Status of Active/Inactive Members**

Once final promises are made, one remains a Dominican for life! Community is a pillar of the lay vocation and active participation in chapter life is the normal expectation. Circumstances however often make this reasonably impossible. Trying to balance these elements, the Council attempted to reach an agreement that would address each issue.

1. The Council affirmed the position that there are no private members. Members are to be received and formed within a chapter setting. Again, we face the “grandfather” situation but where possible all should be affiliated with a particular chapter.
2. Active Members are those who engage in the ongoing life of a particular chapter by faithful attendance and participation.
3. Inactive Members are divided into two categories:
  - a. Inactive Excused - members who have a serious reason for not attending chapters for any period of time, from brief to extended, for serious reasons - illness, advanced age, disability, family situations, extended absence from the area (such as for school, military assignment), those who move and have no chapter to which they may transfer), or those who belong to a chapter that becomes inactive. Upon request to the chapter council they are excused from this obligation. This does not relieve them of fulfilling the other obligations of the Lay Dominican Vocation as best able nor does it mean that they cannot contribute in positive ways allowed by their particular situation to the overall Order.
  - b. Absent - a member who simply does not attend chapter, has not requested excused absence, and evidences no interest in the chapter. Contact should be made with them. There may be some situation that could be resolved. Possibly another chapter would be of interest or they would actually agree to a dispensation from membership.

Will this work? Time and experience will tell. Although it requires some work on the part of the individual chapter to really update their membership rolls, it is a beginning in getting a handle on a common problem.

## Finance

Last summer we were instructed by the Prior Provincial, as part of the reorganization of the finances of the entire Order, to separate ourselves corporately and financially from the Friars. At this point, we are in the final stages of incorporation as a non-profit entity in the State of New York. As part of this, we have had to open separate bank accounts and have total signature authority over this account. This was a radical step for this Province and was taken because it was assumed that we were capable of handling our own matters. This may or may not prove to be the case.

Several years ago the Provincial Council moved collection of dues from within the chapters to a centralized system whereby individuals, not chapters, were responsible for payment of dues. There were several reasons for this. Many chapters complained that the burden of collecting provincial dues kept people from accepting the office of chapter treasurer. Also many chapters spent the entire year collecting dues and did not remit them until all in the chapter had paid. By this process there was no way the Council could make yearly plans or prepared any accurate budget. Also it was felt that if one considered the Dominican vocation a priority in their lives surely the simple act of paying dues in a timely manner would not be a problem. On all counts we were wrong.

By April of this year, we have collected just over 50% of dues from those who have identified themselves as active members. This is after deducting those members who we have already identified as unable to pay because of age, illness and the like. What does this mean? It means that the summer issue of The Torch (unless we find a source of finance outside our membership) will be our last one. It means that the richest and most blessed Province in the world will not be able to meet its commitment to the office in Rome. It means that our formation program (which is the envy of most of the world) will have to go back to the lopsided Xerox copies of the former program. It means that the Rule will continue to be Xeroxed for reception ceremonies or you will have to download one from the net. It means that we will default on the \$36,000 loan made to us by the Friars just to keep us going last year. It means goodbye to our internet site and to the almost completed system of online ordering for the bookstore because of its monthly charge (after one member donated almost \$2000) in equipment and another days and days of program work).

What steps can we take to correct this? Organizationally, we are returning the collection of dues to the individual chapters starting now. I will outline this along with other items taken up by the Provincial Council in next month's *eLumen* (if it pleases the editor). In the meantime I often sit under that window in the House of Studies – the one where St. Dominic prayed for bread for his brothers because they had none and the angels came with bread. I pray and pray for some angels for us and a little bread for our newly-elected Treasurer, Ray Biszko of the New England region, would also be mighty sweet.

## International Council of Lay Dominican Fraternities (ICLDF)

This is the first in a series of reflections on the history and purpose of our International Council and how we work to support the worldwide network of Lay Dominicans.

Hopefully, you have read Dorothy's reflections on the recent Congress and her detailed review of key recommendations. It is not my intent to repeat what she has reported; however, I would like to provide you with some background to help you understand these recommendations and the circumstances in which they were presented.

### ***Our History***

Exactly five years ago, the ICLDF (International Council of Lay Dominican Fraternities) was formed and held its first meeting at Santa Sabina in Rome. We in the United States had the necessary structure in place to elect a North American Representative. This election took place at the DLIPC (Dominican Laity Inter-Provincial Council) meeting in February 2002.

The DLIPC is the regional/national council for the USA and Canada as well as the Vietnamese vicariate. Each province sends the president, provincial promoter and elected delegate to the annual meeting. Each attendee is a voting delegate and the host region makes arrangements for hospitality, agenda and recording secretary. The president of the host region functions as president/facilitator for the meeting. The DLIPC rotates meeting locations and responsibilities annually.

So, you might ask, "How can I be elected to the DLIPC or ICLDF"? Well, each voting member in a chapter elects the chapter council and that council elects a president (formerly known as moderator/prior/prioress) who sits then on a regional council. At the regional level the elective body votes for a president, vice president and delegate to attend the Provincial Council. The Provincial council holds elections every three years to elect a president, vice president and delegate to the DLIPC. So to be a member of the DLIPC or ICLDF you first must serve on your chapter council, regional council, and Provincial council.

Many of you are already familiar with the progression of the electoral process, but I know that this information will be useful to those who are new to the Order and our structure of government. What is interesting to note is that every election affects future events and decisions. No election is without merit. We should always approach voting with a serious attitude because *a randomly elected individual could someday be elected to a higher council position and make decisions that are not in the best interests of all.*

As I mentioned before, the first meeting held in Rome was in May 2002. The five regional areas were defined as Africa, Asia/Pacific, Europe, Latin America and North America. Representatives from Europe and North America were elected.

Asia/Pacific sent their regional president and elected her to the position at the zonal meeting held the following August. Latin America sent their president-elect who also was subsequently elected at their next regional meeting. Fr. Jerry Stookey, O.P., Promoter General of the Laity, appointed the delegate from Africa because the physical hardships and financial challenges of an African regional meeting were yet to be resolved. Since that initial meeting five years ago every zone/region has organized and elected a representative to the ICLDF.

## *Question of Faith*

The question on "What to do with the Lay Dominican 'inactives'?" was addressed by the Provincial Council that met the end of March. It adopted a norm to address inactive members dividing them into "excused" and "absent."

Excused members are those who are dispensed by the chapter from attendance "for serious reasons for a stated or indefinite period." The excused member would fulfill all Dominican obligations as best able and would retain membership in good standing with the chapter. Hopefully, the excused member will be able to return to their chapter, or attend when able.

The absent member has asked to be released from the chapter. The absent member may also have severed all relationships with the chapter and may have made no attempt to join another chapter, or stay in contact with the Family.

# Dominican Rule & Commentary

**Rule 5 Apostolic Mission\* Rule 6 & 7 also deal with Apostolic Mission—  
to be continued in next issue**

Supported by their mutual communion, in the example of Saint Dominic, St. Catherine of Siena, and our predecessors who have enlightened the life of the Order and the Church, we see that they witness their own Faith, attentive to the needs of people in their time and always serving the Truth.

The Dominican identity is not something abstract, but is like a culture in which we give ourselves in its institutional and communal embodiments. This Dominican identity is located in the Rule and in the institutions to which give rise to it and in our communities, both religious and lay. It is reflected in the Order's history by whose example we can follow as we strive to grow in holiness and become Dominican. Besides modeling ourselves on St. Dominic and St. Catherine of Siena, we should look to St. Thomas Aquinas and some of the relatively obscure Dominicans, like St. Margaret of Hungary and Blessed Giorgio Frassati. In the lives of these Dominicans, we will find the great loves that characterized their identity: love of truth, preaching the Gospel, Eucharistic piety and devotion to Mary. The Sister's Motherhouse in Loga was washed away and the brothers' house mostly destroyed. A nearby Gizo village called Nusubaruku was also destroyed.*

from whom we have the fragrant blossom,  
the Word, God’s only-begotten Son,
